Dr. Karl Tragl assumed the position of Chairman of the Executive Board at Bosch Rexroth AG on July 1, 2010 and is additionally responsible for the Business Unit Industrial Applications and global sales activities. Dr. Tragl has been a Bosch Rexroth AG Executive Board member since 2008 and shaped the company's reorientation with a focus on markets and industries.

Dr. Tragl studied Physics at the University of Erlangen/Nuremberg, Germany. Following three years of research work at the German Space Research Institute (DLR), he earned his doctorate in Electrical Engineering from the University of Kaiserslautern, Germany in 1990.

He subsequently began his career in the Central Department of Corporate Planning and Development at Siemens AG in Munich where his work primarily focused on group and international restructuring, growth, and innovation projects. He became a Partner in Siemens Management Consulting, resulting from the 1996 merger of in-house consulting companies. In 1998, he assumed global management responsibility for the Siemens Standard Drives Business Unit based in England.

Dr. Tragl then joined Mannesmann Rexroth AG in Lohr a. Main, Germany and became responsible for world-wide Service in the area of Factory Automation through the merger with Bosch Automationstechnik to become Bosch Rexroth AG in 2001.

In 2003, Dr. Tragl assumed technical leadership of the Electric Drives and Controls Division at Bosch Rexroth AG, for which he was elected Chairman of the Board in 2004. He has been in charge of the company's global sales activities as a Bosch Rexroth AG Executive Board Member since 2008.

In addition to his professional activity, Dr.-Ing. Karl Tragl is Member of the Governing Board of the German Engineering Federation VDMA, Member of the Advisory Board of the Mechanical Engineering Summit, Member of the MDA Advisory Board of the HANNOVER MESSE and Member of the Advisory Board in the Field of Electric Drives of the Central Association of the German Electrical and Electronics Industry ZVEI.
